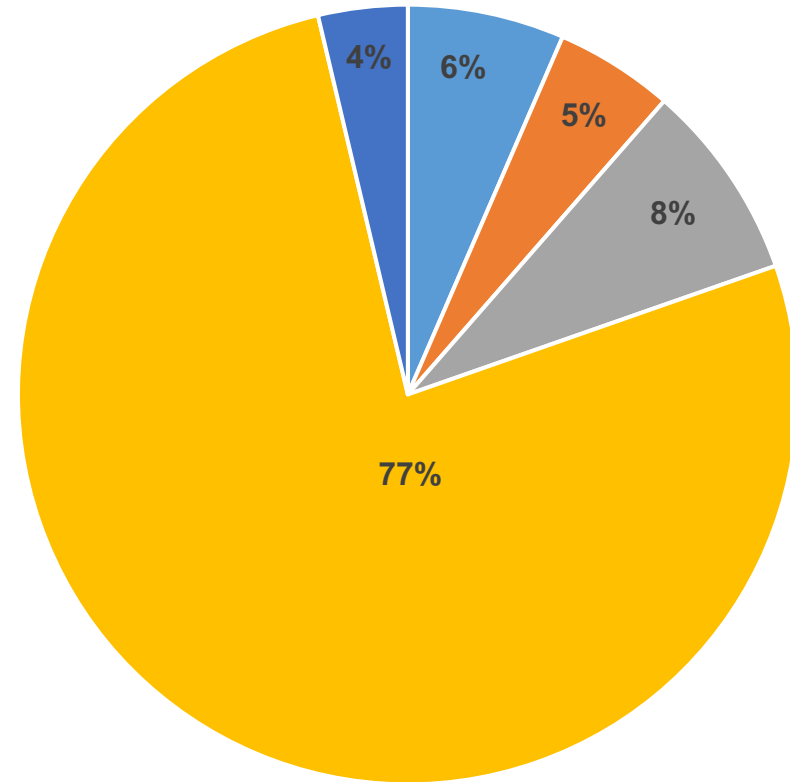
What is the IIJA/BIL?

- Passed into law by Congress in November 2021
- It authorized \$1.2 trillion for roads, bridges, and water infrastructure along with investments in broadband, energy, and other improvements
- \$550 billion of the \$1.2 trillion are slated for “new” investments / programs
- Some funding will directly be distributed to states and remaining funding will be eligible for competitive direct grants (discretionary funding)

Agencies that Receive BIL Funding Most Applicable to Cities

- Department of Agriculture: fund existing and new USDA Rural Development programs
- Department of Commerce: Community and Economic Development programs
- Department of Energy: Electrical grid and power infrastructure
- Department of Homeland Security: FEMA programs, public safety and cybersecurity
- Department of Transportation: Highways, bridges, airports, transit, rail, others
- Environmental Protection Agency: Water infrastructure
- Other

New Investments / Programs in BIL

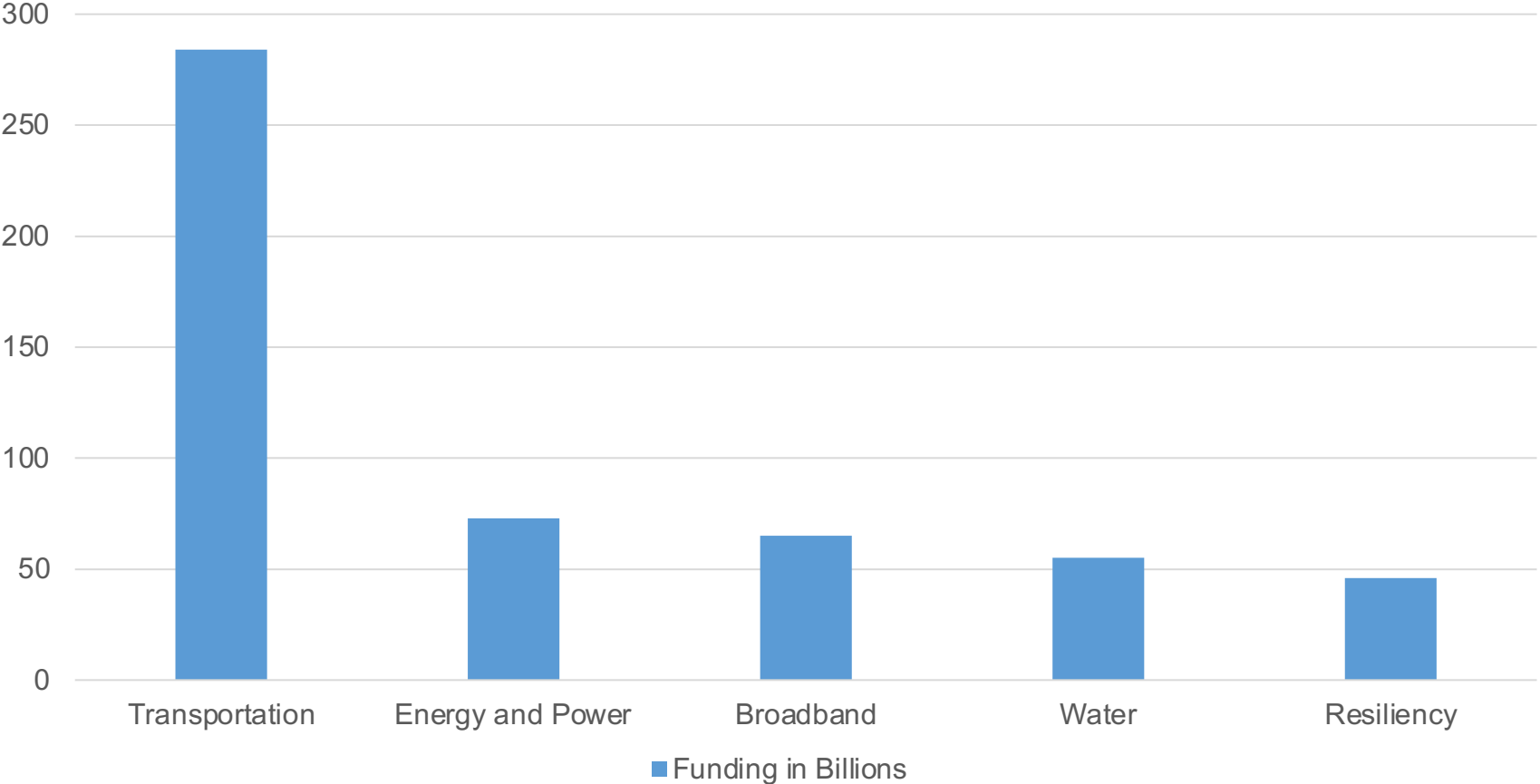
New investments in transportation include over \$280 billion for:

- Bridge repair and replacement
- Airports
- Passenger and freight rail
- Public transit
- Ports and waterways
- Electrical vehicle charging stations
- Safety

New Investments / Programs in BIL

- Power and Grid: \$66 billion for grid reliability and resiliency
- Broadband: \$65 billion to make broadband more accessible
- Water: \$55 billion, including significant funding for replacing lead pipes and service lines
- Resiliency: \$47 billion for cybersecurity, waste management, and flood and fire mitigation

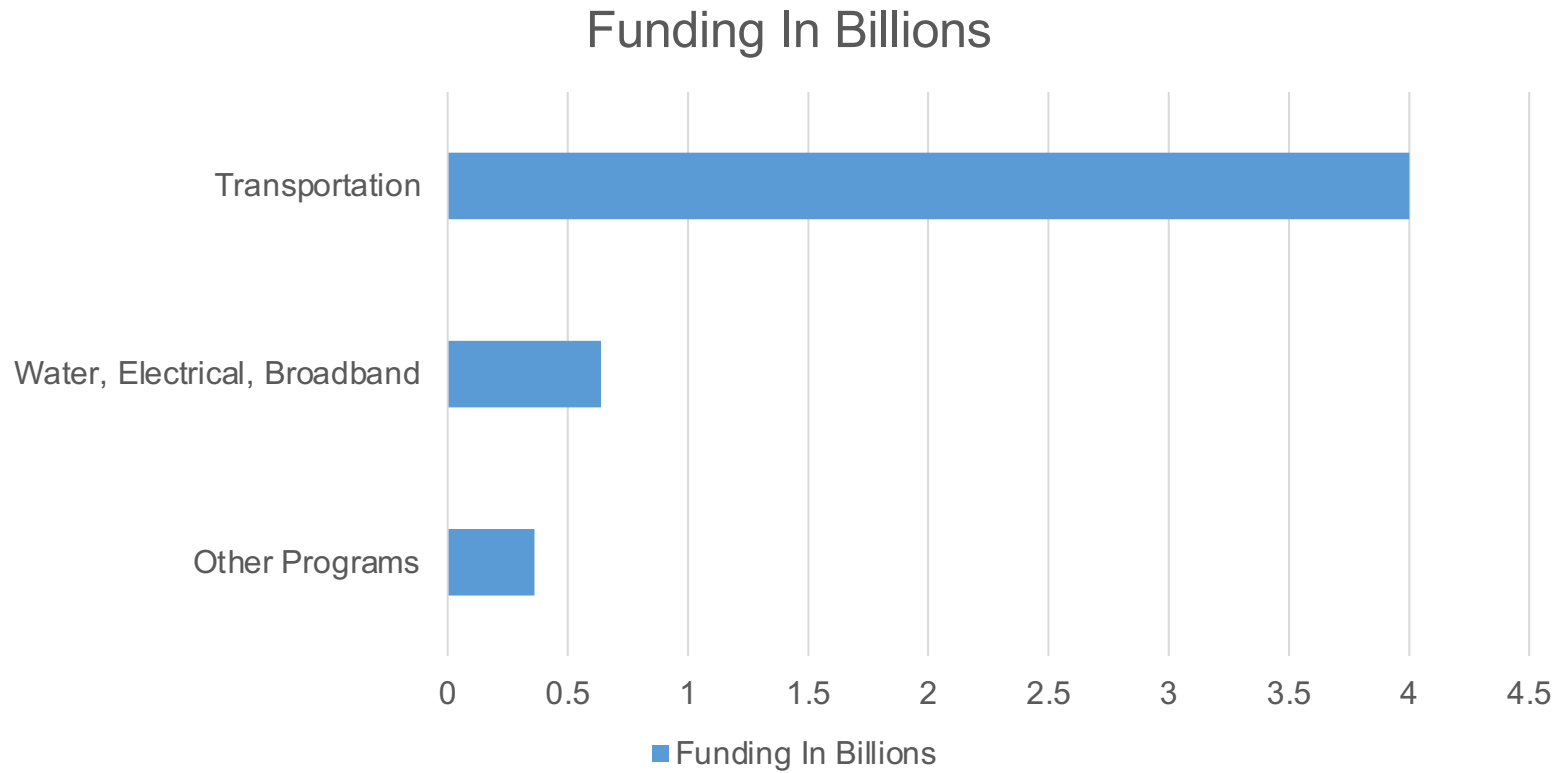


BIL Funding for Iowa

In addition to the discretionary/competitive grant funding available through a federal agency, it is expected Iowa will receive at least \$5 billion in pass-through funding over 5 years. The funding will be allocated to both existing and new state programs, and will be available for:

- Transportation: highways, transit, bridges, airports, and charging stations
- Water, electrical infrastructure, and broadband infrastructure
- Housing, arts, health, and safety
- Other

Iowa Transportation Funding

Federal-Aid Surface Transportation Block Grant (STBG) Program

- Funding for roads on federal-aid routes, bridges on any public road, and transit capital improvements
- Apply for funding through regional planning organization: iowacog.com/find-your-cog

Revitalize Iowa's Sound Economy (RISE) Program

- Targeted toward value-added activities to provide maximum economic impact on primary and secondary roads, and some city streets
- Funding is generally limited to development of industrial, manufacturing, and other similar uses and cities partner with developer on the application

Iowa Transportation Funding

Other notable IDOT programs include, but are not limited to:

- City Bridge Program
 - DOT/DNR Fund
 - Airport Improvement Program
 - Highway Safety Improvement Program
 - State Recreational Trails Program
 - Railroad Crossing Safety Program

Funding Through Iowa SRF

The Iowa State Revolving Fund (SRF) receives pass-through funding through the EPA. Funding through the SRF is available to applicants for drinking water and clean water projects. The SRF was awarded over \$620 million in BIL funds to assist eligible projects, including supplemental assistance, emerging contaminants and lead service line replacement.

SRF Grants / Loan Forgiveness

The SRF considers a number of factors to determine if a community is eligible for grant funding, including:

- Project Priority: Need for the project
- Socioeconomic Score: Disadvantaged status of the community
- Household Burden: Current rates / community's ability to afford the project

Funding Programs Through IEDA

The Iowa Economic Development Authority has several programs that will receive BIL pass-through funding, which include, but are not limited to:

- Destination Iowa: Sense of place and enhance tourism
- Various Community Development Block Grants (CDBG) for disadvantaged communities
- Empower Rural Iowa: Investing in, growing and connecting rural Iowa
- Low interest loan programs for nuisance properties and energy infrastructure improvements
- Many more programs which revolve around community and economic development

Inflation Reduction Act (IRA)

- Signed into law in August 2022
 - Approximately \$370 billion of investment (tax credits, grants, loans) in renewable / clean energy and combating climate change
 - For programs eligible to cities, a direct payment can be made in lieu of tax credits

Inflation Reduction Act (IRA) Continued

Examples of programs/funding cities will be eligible for include:

- Renewable Energy: solar and wind
- Clean Vehicles: Electric and Hybrid
- Carbon Pollution Reduction Planning Grants
- Pollution Reduction Implementation Grants
- Other programs on the horizon related to renewable energy and reducing greenhouse gas emissions

Applying for Funding

Grant Lifecycle

1. Pre-award Phase: funding opportunity is announced, and an application is submitted
 2. Award Phase: Award decision is made, and awardees are notified
 3. Post Award Phase: Implementation, reporting, and grant closeout
-

Types of Grants: Competitive Grants

- Based on merit, applied for directly through an agency, and awarded through a process which requires a project budget and a proposal to apply for the grant. These grants are also known as “discretionary” funding.
- Awardees are chosen by a team of reviewers who read your grant proposal and evaluate your project to determine if it is a good fit for their funding.
- The outcome of a competitive awarding process is not predetermined and include a lot of rules and regulations to keep the awarding process fair and equitable.
- It is crucial to understand what is being asked of you in the application, and to have a very good understanding of your proposed project to make your application as competitive as possible.

Types of Grants: Pass-Through Grants

- Federal agencies issue pass-through funds to a state agency. The allotments Iowa has received through BIL are an examples of pass-through grants.
- States distribute these funds as competitive or non-competitive based on terms and authorizing legislation. For example, if it is a formula funding stream at the federal level, it will be at the state level as well (think CDBG grants).
- Applicants apply for funding through a state agency.

Types of Grants: Formula Grants


- Awardees are predetermined and funding is mathematically allocated to recipients.
- Typically, a recipient must meet certain criteria thresholds to be considered for an award. Criteria can be based on several factors such as population and a community's low to moderate or median income.
- As it relates to BIL funding, formula grants are awarded to states, and the state agency chooses which project to support at the local level that meets the criteria requirements to receive the funding.

Types of Grants: Continuation Grants

- Awards extend beyond one year.
- Applications for continuation awards are assessed based on the availability of funds for consecutive years.
- Grant performance is vital first year of the award; maintaining compliance and meeting the objectives identified in the grant application.
- Continuation awards are normally not for infrastructure projects and provide funding to non-infrastructure programs.
- ARPA funding is an example of a continuation grant.

Applying for Federal Grants: SAM.gov Account

- City must be registered through SAM.gov to be eligible to apply for grants
- Registration renews annually and needs to be current
- You will need your city's SAM Unique Entity Identifier (UEI) for the application, and it can be found on the SAM.gov site.

Applying for Federal Grants: grants.gov Account

- Most Federal grants require you to submit applications on the grants.gov site
- Register an account for your city at grants.gov
- Searching for grant opportunities on the site is easy and the search can be narrowed to eligibility for city governments

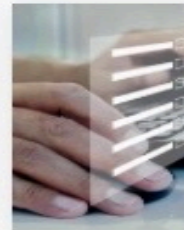

Grant Tips

Plan Ahead

- Search and prepare for the upcoming opportunity
- Review Notice of Funding Opportunity (NOFO) to understand the needed local match and if partners are needed
- Confirm grants.gov and SAM.gov accounts are up to date

More About the NOFO...

- Are you able to realistically meet all requirements and eligibility criteria? If not, the opportunity more than likely is not the right fit.
- If it appears to be the right fit, identify stakeholders and enlist the assistance of consultants, as necessary to assist with the application.

Grant Tips

About the application:

- Follow the requirements to the letter; follow word count, character count, include everything they are asking for or risk elimination.
 - Attend webinars (sometimes required) if they are available.
 - If it is allowed, reach out to the contact for the grant with questions. They may be able to provide information to strengthen application.

Grant Tips

Application Narrative: Be Specific and Differentiate Yourself from the Competition

- Who will it benefit; citizens and/or businesses?
- How will it improve quality of life and what are the long-term benefits to your city?
- What makes the project you are requesting funding for and your community unique?
- Use photos, statistics, records, and available documentation if allowed by the NOFO
